My contributions to this year focused on a return to programming while building relationships in the community. No matter if there is a pandemic, in social services the show must always go on! We have been fortunate that Carol and now I, have been able to continue meeting with clients for emergency assistance with restrictions in place. Gratefully, Holiday Spirit was able to persevere under Carol this past season. Kaneland families were still able to participate, and 111 children benefited. Our donors still came out in full force. Although it is clear I have big shoes to fill, I am up for the challenge and appreciate the warm welcome. Seeing all the folks willing to support our little agency despite their own hardships has been such an affirmation for my choice in vocation. - *Good Grief Day Camp* Week long day program for children who have lost a parent or sibling, ages 6-12 years of age.




Community Services


- *Kaneland Coalition for Healthy Youth--* a local coalition of churches, non-profits and schools working to promote awareness of the dangers of alcohol and drug use and encourage mental health.
- *The Community Care Team* a network of adult natural helpers who receive specialized training in how to effectively listen, respond, and refer friends and neighbors for help and assist area residents through a variety of volunteer opportunities.
- *Emergency Assistance Programs* limited, short-term financial assistance to local individuals through the Good Samaritan Fund, Holiday Spirit and Salvation Army Extension Services. Help also available through the Clothing Exchange Clothing Closet.

West Towns Human Services

- *Referral and Advocacy* free, confidential resource and referral service links area residents to over 85 health and human agencies in Kane, Kendall & DeKalb counties
- *Two Local Offices* space available for area mental health providers to see clients close to home in Elburn and Sugar Grove
- *West Towns Community Resource Team* group of 20 local agencies that meet monthly to discuss service needs in rural western Kane County.

Demographics

In FY 2021, Conley Outreach touched over 1,839 lives in our community.

367 families were linked to over 85 health & human service providers through the West Towns Network. Over 785 requests for help were answered.

67 people received financial assistance from one or more of our benevolence funds and COVID 19 grant; 111 children received toys through Holiday Spirit.

359 people received clothes from the Clothing Exchange Closet.

19 volunteers provided over 248 hours of community service through the Community Care Team

Over 416 people received grief support through one of Conley Outreach's programs; over 152 hours of direct support were provided.

500 students, parents and community members received information about the dangers of substance abuse through the Kaneland Coalition for Healthy Youth.

2021 Highlights

GOOD GRIEF DAY CAMP

The resumption of the Good Grief Day Camp was a very exciting highlight to our year. Like the rest of the world our services had been put on pause during the pandemic and it was essential for us to be able to be there for the kids who need us. The camp was held at the end of June for children ages 6-12 years old who lost a parent or sibling. We were hosted by Farm Friends on their lovely property in Big Rock, IL. This year we were able to provide the same wonderful programming the children have come to love such as theatre and art activities with some new additions. We were pleased to be joined this year by Julia the Comfort Dog from LLC K-9 Comfort dogs and her handler, Terri who assisted the kiddos in their lessons on feelings. We also were excited to change things up a bit with goat yoga provided by Live Learn and Lead to help the kids work through their trust lesson. Pictured below is one of are awesome volunteers. Thankfully, he and our other volunteers did not hesitate to return when asked! Without their assistance this event could not have happened.

Return to Outreach and Festivals

May 2021, saw the return to events and outreach with the Elburn Chamber's Health Fair held at Lion's Park in Elburn. Conley Outreach Community Services participated in the day along with a number of local agencies to promote wellness within the community. It was a hot day but a great kick off to the return of festival season!






